## DIRECTION FOR USE

- **Use Gloves included at all times.**
- Remove any product that is attached to the gun.
- Spray DEALCLEANER™ on the gun valve and clear it of any un-cured urethane.
- Once valve is clean, attach DEALCLEANER™ to gun valve.
- Point the gun away for people and sources of ignition. Point it to a container that is suitable for collecting solvent.
- Press the trigger multiple times to dissolve and clear any un-cured urethane foam inside the gun.
- Once you see the cleaner dispensing from the gun wait for a couple of minutes for cleaner to dissolve the urethane inside the gun.
- Pull trigger a few more times to make sure gun is completely clean and only solvent is coming out.
- You can now store the gun for long term storage and reuse with other products.
- **IMPORANT** - Cured foam cannot be removed with DEALCLEANER™. Do not use pointed or sharp objects to clean gun.
- Test the use of solvent before using it to remove cured material from other surfaces or substrates.
